Terms of Student Agreement

- Schedule:** I understand that classes are offered throughout the week and that class schedules are subject to change with or without notice. All classes are held at The Raminfard School of Arts located at 10604 W. Pico Blvd., Los Angeles, CA 90064.
- Tuition:** I understand that monthly tuition is due upon the first class session and at the start of each month thereafter. Pricing is subject to change without notice. Single classes are available for adults and kids at the going rate of \$50 per class, which is due and payable at the time each individual class is taken. *All sales are final*; thus tuition is non-refundable.
- Cancellations and Make-ups:** I understand that students are permitted to cancel and/or make-up a class at the instructor's discretion; however, ongoing cancellations and requests for make-up classes are discouraged. I promise to make my best effort to come regularly, and will let my instructor know if I am running late, or will not make it to class, due to a last minute issues or emergencies.
- Attendance:** I understand that students are expected to come prepared and be on time to class regularly. Please note there may not be class on the following days: New Year's Day, Easter Day, Mother's Day, Memorial Day, Father's Day, Labor Day, Thanksgiving, and Christmas Day.
- Conduct:** I understand that students are expected to behave and respect the instructor, their fellow students, and the studio space. Failure to do so will result in the student being asked to leave the class for the particular teaching session and may result in expulsion from the school. I promise to adhere to all oral and written rules said or posted within the studio space.
- Liability:** I understand any and all risks inherent to drawing and painting shall be assumed by the undersigning student or guardian, whichever applicable. The Raminfard School of Arts, its principals, employees, agents, and/or affiliates shall not be held liable for any claims, liabilities, and/or demands that are made/incurred as a result of injuries, illness, loss of property and/or income, damage to property, negligence, and/or other cause(s) of action whatsoever that is a direct or indirect result of any act/event associated with the course(s) being offered and/or the activities in such courses. EXCEPT AS EXPRESSLY SET FORTH HEREIN, THERE ARE NO OTHER WARRANTIES, INCLUDING, BUT NOT LIMITED TO THOSE WARRANTIES THAT MAY BE IMPLIED BY LAW SUCH AS THE WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
- Supplies:** I understand that if a student is asked to leave a class or a session of classes, or wishes to no longer attend, they must claim their supplies and art work within 30 days from their last visit to the studio. All materials including paintings will be disposed of thereafter, unless special arrangements have been made with and approved in writing by the instructor of the Raminfard School of Arts prior to the stated 30 day period.
- Photographic Release:** I hereby agree to permit The Raminfard School of Arts, its principals, employees, agents, and/or affiliates to photographic and make film records of me and my invitees for the purposes of promotional and commercial use.
